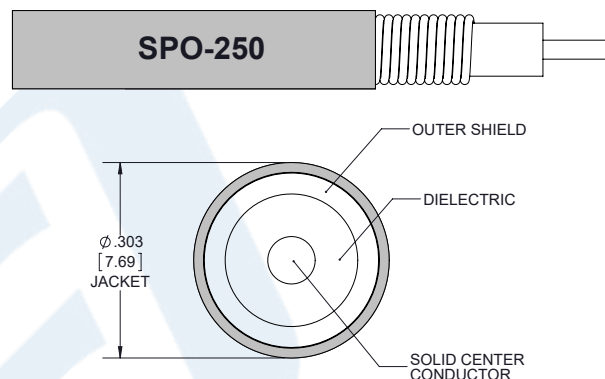

Our low PIM design also offers excellent passive intermodulation performance with PIM levels better than -160 dBc.

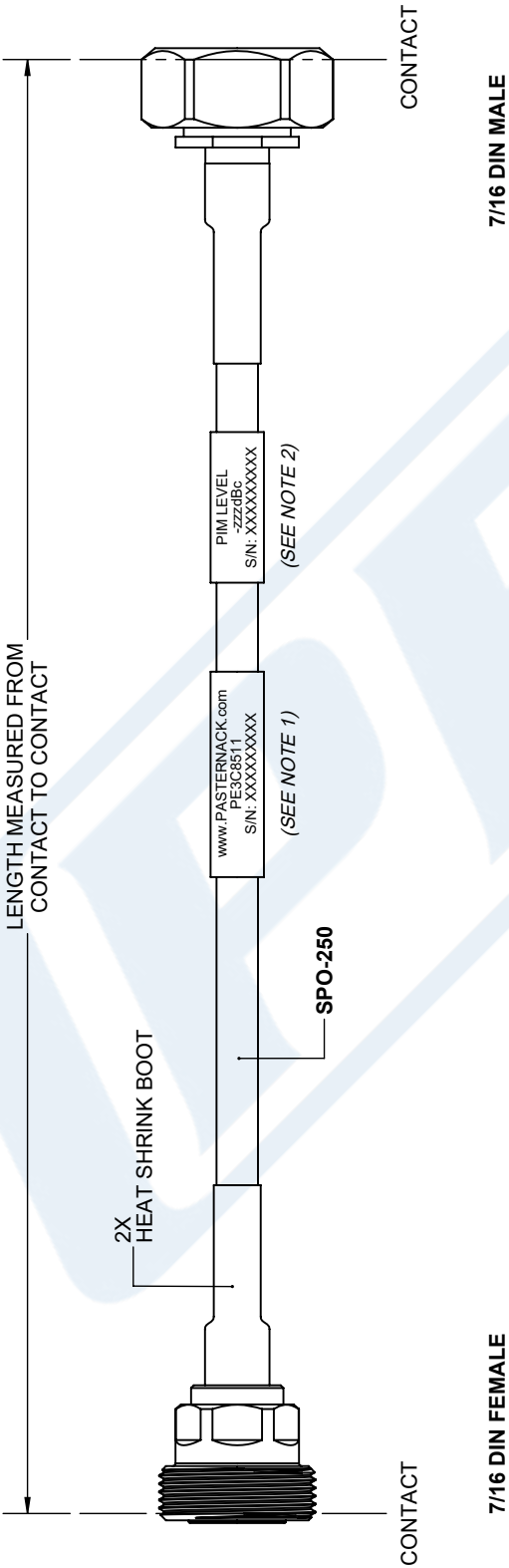
